ELIGIBILITY REQUIREMENTS FOR NEW MEMBERS

1. Must reside within the boundary area as voted upon by the membership. (1a)
2. Must be at least 21 years of age.
3. Those with interest in other yacht clubs, such as members, officers, board members, share holders, etc. may not vote on Fifth street yacht club Constitution and by Law changes. (3a)
4. The club has been and is organized for pleasure boaters and their families. (4a)
5. Must own a boat, which has passed the Coast Guard or Auxiliary inspection by end of the probation year.. (5a, 5b)
6. The 5th Street Yacht Club is looking for active membership. Therefore, the following minimum participation is expected:
 - Attend at least on half (1/2) of the regular membership meetings during the next 12 months.
 - Attend as may club functions as possible.
 - Work on at least two (2) Club events during the next 12 months.
 - Work at either the Spring, or Fall, Club property clean up.

Notes:

- 1a March 1995, amended to allow up to ten (10) new members from outside the above boundary limits.
Limits prior to march 1995 are all of Racine County and from with Wisconsin/Illinois state line, north to the South Milwaukee line, west from Lake Michigan to Highway 45.
- 3a Must not b a member of another club.
- 4a Therefore: Must not be an owner/operator of a commercial boat or a boat for hire (mmmm 199X, waived by vote of the Board and Club members)
- 5a mmmm 199x, waived the inspection requirement by vote of the Board and Club members
- 5b mmmm 1999x, amended to allow 10 members without boats by vote of the Board and Club members.

If for some reason you decide not to join the club at this time, future consideration for membership will take place only after you have filled out and submitted a new request card, and go through the procedures as a new applicant.
